<u>Instruction for Change of Authorised Signatories and/or Account Mandate for Sole Proprietorships /</u> Partnerships

- 1. All new authorised signatories are required to provide the documents below:
 - > Clear photocopies of their identification card or unexpired passport (6 months before expiry).
 - Proof of address by new signatories who are foreigners. Examples of proof of address include utility bills or bank statements dated within 3 months.
- 2. Certified true copies of identification documents are to be provided by bank staff, a notary public, lawyer, certified public or professional accountant or chartered corporate secretary.
- 3. The Bank may request additional documents.
